Registration:

Under this act, all clinical establishments, including Homeopathy clinics and hospitals, must be registered with the appropriate authority. Students should understand the registration process, including the documents required and the fees involved.

The second year students and interns are oriented towards homoeopathic practice and establishment of homoeopathic clinic details of teaching session: although clinical establishment act is not a part of syllabus of forensic medicine as given by CCH. The department of Forensic Medicine and Toxicology has incorporated this act. The department of FMT has included clinical establishment act 2010 in the teaching plan during the last quarter of each academic year since last four years. Total no of session are devoted for this act are —

- 1. Two session for second year BHMS (each session is of 1-2 hour) which include introduction, objectives, states who implanted clinical establishment act, details of minimum standard of clinical establishment act.
- 2.One session for intern during orientation programme which include revision of cold act. OBJECTIVE OS SESSION 1:-
- 1.Student should know about importance of clinical establishment act.
- 2.Student should know about aim and objective of the act. Session 1 is concluded by student with summarization and assignment of the act.

OBJECTION OF SESSION 2:-

- 1. Student should know what are the minimum standard of facilities and services for improvement of public health session.
- 2.It is concluded with summarization and assignment of the act. During interns orientation programme this act again gets revised.

INTRODUCTION:- The clinical establishment act was passed by parliament of India on 17th august 2010.
OBJECTIVE:-

- 1. An act to provide the registration ang regulation of clinical establishment in the country.
- 2.To prescribe minimum standards of facilities and services which maybe provided by them.
- 3.Desired public health improvement
- 4.To eastablish digitial register of clinical establishment at National, State and District level. To prevent quackery by unqualified practitioners by introducing registration system, which is mandatory.

APPLIES TO:-

- 1. Arunachal Pradesh, Himachal Pradesh, Mizoram, Sikkim and the union territories
- 2. Likely to be adopted by all states.

Licensing: Depending on the state or region, specific licensing requirements may apply to Homeopathy practitioners. Students should be aware of these requirements and procedures for obtaining licenses if necessary.

Fees and Penalties: The act prescribes fees for registration and renewal, and it outlines penalties for non-compliance. Students should understand the financial aspects of operating a Homeopathy clinic within the legal framework.
